#### 8) Community Matters/Local Place Plan

#### Balloch Castle County Park Regeneration Group

Sally Page and Audrey Baird gave a presentation on the formation and objectives of the BCCPRG followed by a Q&A.

#### Kilmaronock Old Kirk Trust

Willie Roxburgh gave a presentation on the progress and next steps for the KOKT in the restoration of the Old Kirk including an explanation of the plans for internal alterations and development of the grounds recently acquired adjacent to the Kirk.

#### LPP

Rob Vincent gave an update on the progress of the LPP through to the most recent community consultation meeting last month. Currently the text is awaiting the addition of maps expected next week. Once KCC have reviewed the plan it will be made available for elected members of WDC and neighbouring communities for a 28 day period for them to comment. The plan will then be officially submitted to LLTNPA & WDC for registration.

From then on, there will need to be an Implementation Plan to bring forward the projects identified within the LPP.

#### 9) Kilmaronock Community Trust

KCT trustees will be meeting next week and will discuss the LPP with a view to progressing some of the projects that have arisen.

#### 10) National Park Issues

David Mackie (DM) was present to discuss recent NP initiatives such as the National Park Partnership Plan and the development of the next Local Development Plan. The government are proposing two more National Parks at Lochaber and Dumfries & Galloway.

DM was advised of the lack of notice to local farmers to contribute to recent consultations.

KCC have recently been sent notice of a consultation on <u>Scotland's Strategic Framework for Biodiversity</u>.

#### Waste & Recycling

Since the last meeting, Cllr Sorrell helped us get a response from WDC regarding a contact point at Barr Environmental. After discussion, it was decided not to pursue a visit to Barr at Auchencarroch but instead to ask WDC Waste Services Manager to join our next meeting to talk about recycling strategy.

#### Balloch Library

It was recently announced that Balloch Library was to be relocated from its present building to a space within Balloch School Campus. There was no public consultation or information on what options were explored, if any, other than complete closure. Cllr Sorrell was unable to attend tonight so after discussion it was decided to write to her and include any response with these minutes. See below...

# Post meeting Cllr. Sorrell informed us that there was no budget available to keep Balloch Library in its present location.

"In May 2022. I was elected to Lomond ward. We were left with a £13.8 million debt and with inflation and the pay rise it jumped to £21.8 million. As a Labour administration we had to implement the cuts while safeguarding the most vulnerable in West Dunbartonshire.

The Library has been on the cards many times for closure and each time we have saved it. Balloch Library will not close but will be re located to Balloch Campus which is 20 metres away.

The Library will have its own enclosed entrance and the users will not be amongst the kids who go to this school."

### 12) Correspondence

Police report: Three recorded crimes – vandalism, extortion and wildlife crime. Further information was requested, as the police were not due to be present, but it did not arrive in time.
