9) Kilmaronock Community Trust

Green Energy Summit

KCT are coordinating with local green energy businesses to run an event in the Hall dedicated to promotion of green energy solutions. The target is a meeting before end of year, if possible, while high energy bills are on people's minds.

The rough brief is as follows:

KCT to host a public event in KMH around November 2023 to help the community to engage with the Climate Crisis, find out more about what their options are and steer them towards the right decisions for themselves as well as for the planet. It is intended to have presentations, displays and an opportunity to discuss options. As well as initial raising of awareness, the event should provide a basis for an Action Plan for further activity.

<u>Roads</u>

We are awaiting a suitable date for a meeting with Roads dept.

It was brought to our attention that surfacing works for the UCI Cycling road race resulted in covering over drains at Wards corner. These need to be cleared before winter.

We were informed of issues with bin collections in Church Rd. Regularly missed collections, bins being taken away and not replaced. Some bins emptied, some not. Poor communications between residents, bin men and WDC waste dept.

GM & DSP were in discussions with WDC regarding their charges for water tests. WDC have now halved their fees.
